WHEREAS, presented to this Sangguniang Bayan for legislative action was the Municipal Nutrition Committee Resolution No. 01 series of 2022, re: A resolution directing the Local Nutrition Committee of the Municipality of Kapalong, Davao del Norte to support and implement Republic Act No. 11148, otherwise known as the "First 1,000 Days Law", or the "Kalusugan at Nutrisyon ng Mag-Nanay Act," which was favorably indorsed by the Office of the Mayor per indorsement letter dated March 8, 2022 and received on March 9, 2022;
