Whereas, the OPT Plus is used for local nutrition action planning particularly in quantifying the number of malnourished children and in identifying who will be given priority interventions in the community;

Whereas, OPT PLUS aims to provide appropriate health and nutrition services to preschoolers whose weights fall below normal and assess the effectiveness of the local nutrition program;

Whereas, said measure was calendared on June 6, 2022 regular session, and was recommended for approval per Committee Report No. 65 dated June 8, 2022;


