**APPROVING BY OPERATIONS OF LAW IN
ACCORDANCE WITH SECTION 56(D) OF REPUBLIC
ACT NO. 7160, MUNICIPAL RESOLUTION NO. 87,
SERIES OF 2022 OF THE SANGGUNIANG BAYAN OF
KAPALONG, THIS PROVINCE, "A RESOLUTION APPROVING
THE ANNUAL INVESTMENT PLAN (AIP) FOR CY 2023
OF THE MUNICIPALITY OF KAPALONG, DAVAO DEL
NORTE, DULY ADOPTED BY THE MUNICIPAL DEVELOPMENT
COUNCIL (MDC) PER ITS MDC RESOLUTION NO. 02
DATED JULY 20, 2022", SUBJECT HOWEVER, TO
THE RECOMMENDATIONS HEREIN STATED**

WHEREAS, an indorsement dated October 12, 2022 of Mr. Edwin E. Ganiera, MPA, Secretary to the Sanggunian, duly received by the Office of the Secretary to the Sangguniang Panlalawigan on October 21, 2022, indorsed to this August Body, Resolution No. 87, Series of 2022 of the Sangguniang Bayan of Kapalong, this Province, was presented for appropriate legislative action;

WHEREAS, the aforesaid measure was referred to the Committee on Human Settlements, Planning and Development, for review and recommendation;

WHEREAS, the Annual Investment Plan (AIP) for Calendar Year (CY) 2023 of the Sangguniang Bayan of Kapalong contains additional priority Programs, Projects and Activities (PPAs) for funding under the 20% Development Fund and Municipal Disaster Risk Reduction Management (MDRRM) Work and Financial Plan and PPAs for new items under other sources, as embodied in Municipal Development Council (MDC) Resolution No. 02, Series of 2022;

WHEREAS, the aforementioned measure is considered deemed approved by operations of law as enshrined under Section 56 (d) of Republic Act No. 7160 or the Local Government Code of 1991;

WHEREAS, the Committee thoroughly discussed and deliberated on the merits of the said measure and per Committee Report No. 66 dated November 28, 2022 finally recommended to approve the same subject however to the recommendations herein stated;

WHEREFORE, BE IT RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve, as it is hereby approved by operations of law in accordance with Section 56(d) of Republic Act No. 7160, Municipal Resolution No. 87, Series of 2022 of the Sangguniang Bayan of Kapalong, this Province, "A Resolution approving the Annual Investment Plan (AIP) for CY 2023 of the Municipality of Kapalong, Davao del Norte, duly adopted by the Municipal Development Council (MDC) per MDC Resolution No. 02 dated July 20, 2022", subject however, to the recommendations herein stated;


RESOLVED, FURTHER, that the Sangguniang Bayan of Kapalong shall take into consideration the following recommendations for the findings being observed by the Sangguniang Panlalawigan, this Province:

1. To Provide Income and Expenditures Projections. The projected income and expenditure determines how much will be funded to various fund sources (e.g. general funds for PPAs, 20% Development Fund, 5% Calamity Fund), these fund sources constitute the Local Fund Source of the Annual Investment Plan (AIP)/Local Development Investment Program (LDIP).
2. The local fund sources determine the estimated budget for the next Fiscal Year, for that reason, it is highly recommended that the local fund sources be segregated from the supplemental budget and other funds for funding from other sources.
3. To indicate the specific locations of the project especially on infrastructure projects since there were some projects that have no definite location indicated, especially road sections and barangay projects.
4. Review on Climate Change Expenditure Tagging (CCET). Some tagged under CCET may not be necessarily be tagged under it, while other PPAs may necessarily be tagged but were not identified.

RESOLVED, FURTHERMORE, that copy of this resolution be furnished the Sangguniang Bayan of Kapalong this Province through Mr. Edwin E. Ganiera, MPA, Secretary to the Sanggunian for their record and appropriate action.
