3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from **Local Government Unit of Kapalong, Province of Davao del Norte** and inspect the Bidding Documents at the address given below from **8:00 A.M. to 5:00 P.M., Mondays to Fridays**.
5. A complete set of Bidding Documents may be acquired by interested bidders on **March 23, 2022** from given address and website/s below **and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php 25,000.00..** The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person, by facsimile, or through electronic means.
6. The **Local Government Unit of Kapalong, Province of Davao del Norte** will hold a Pre-Bid Conference on **April 4, 2022 at 10:00 AM** which shall be open to prospective bidders at **BAC Secretariat Office Supply Office Municipal Compound, Maniki, Municipality of Kapalong, Province of Davao del Norte**.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below, on or before **April 18, 2022 at 10:00 in the morning**. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 16**.
9. Bid opening shall be on **April 18, 2022 @ exactly 10:00 in the morning** at the given address below. Bids will be opened in the presence of the bidders’ representatives who choose to attend the activity. Bid Evaluation will be on April 19, 2022 and Post Qualification is on April 21, 2022.

The **Local Government Unit of Kapalong, Province of Davao del Norte** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.

Pursuant to Sec.7.05 (b) of IFAD General Conditions for Agricultural Development, Financing, bidders, suppliers, contractors, sub-contractors and consultants are required to:

(i) Allow full inspection by the Fund of all bid documentation and related records;

(ii) Maintain all documents and records related to the bid contract for three years after completion of the bid contract: and

(iii) Cooperated with agents or representatives of the Fund carrying out an audit or investigation.
