INVITATION TO BID

CONSTRUCTION OF DRAINAGE CANAL AT VILLA CLEMENTA, BRGY. MANIKI, KAPALONG, DAVAO DEL NORTE

- 1. The Local Government Unit of Kapalong, through the 20% Dev't.Fund CY 2024 intends to apply the sum of Three Million Pesos Only (P 3,000,000.00) Construction of Drainage Canal at Villa Clementa, Brgy. Maniki, Kapalong, Davao del Norte/002-2024 being the Approved Budget for the Contract (ABC) to payments under the contract for each lot. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.
- 2. The Local Government Unit of Kapalong now invites bids for the above Procurement Project. Completion of the Works is required **180 calendar days**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- 4. Interested bidders may obtain further information from Local Government Unit of Kapalong and inspect the Bidding Documents at the address given below from 8:00 A.M. to 5:00 PM.
- 5. A complete set of Bidding Documents may be acquired by interested bidders on April 29, 2024 from given address and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of (P 5,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees will be presented in person during bid opening as part of Eligibility Requirements.
- 6. The Local Government Unit of Kapalong will hold a Pre-Bid Conference¹ on **May 7, 2024** at 10:00 AM at Supply Office LGU Compound Maniki, Kapalong, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address as indicated below, on or before **May 20, 2024 at 10:00 A.M.** Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 15.
- 9. Bid opening shall be on **May 20, 2024 at 10:00 A.M** at the given address below **.** Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

May be deleted in case the ABC is less than One Million Pesos (PhP1,000,000) where the Procuring Entity may not hold a prebid conference.

- 10. Interested Bidders shall submit Letter of Intent (LOI) and Notarized Authorization as representative from the proprietor to attend the Bid Opening.
- 11. The Local Government Unit of Kapalong reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
